

## **Information about the processing of the personal data of Participants**

### **1. Purposes of the processing**

The personal data provided will be processed by the Operator of the Milan Junior Camp, as indicated in the inscription, by Milan Entertainment srl and by its parent company AC Milan S.p.A., that are joint data controllers, to process the application to enrol the minor in the Milan Junior Camp and guarantee related sports' activities.

### **2. Processing procedure**

The personal data may be processed as hard or soft copies and entered in relative databases that may be accessed by and therefore come to the knowledge of operators appointed to manage and supervise Milan Junior Camp activities, that may consult, use, process and compare data and carry out any other appropriate operation, also electronically, in compliance with necessary legal provisions, to guarantee, among others, the confidentiality and security of data as well as the accuracy, updating and relevance of data in compliance with declared purposes. Automated decision-making processes are not in place.

### **3. Provision of data**

The provision of data is optional but refusal to provide requested information could mean it is not possible to enrol in the Milan Junior Camp or could cause organisational difficulties.

Essential and indispensable data to enroll in the Milan Junior Camp include medical certification proving physical and mental fitness to play sports, the name, surname and date and place of birth of the participant, as well as the name, surname, telephone number and email address of the parent.

Failure to provide remaining data indicated in the form will not affect the enrolment procedure.

### **4. Scope of the communication of data and dissemination**

Data will be processed by personnel of the Data Controllers, or by third parties and professionals, necessary to provide the services, in a capacity as persons in charge of the processing or data processors. Moreover, notices may be necessary to ensure compliance with obligations arising from laws concerning the Public Authorities or in any case for the purposes of the legitimate interests of the data controller, such as protection from fraud, as well as for making claims through the courts.

### **5. Data retention period**

The personal data collected, also considering any choices of data subjects relative to requests to have data cancelled or consent withdrawn, during the processing, will be processed for a period necessary for the purpose for which the data were obtained, in compliance with contractual agreements with the data subject, according to applicable laws or regulations or, for a period considered appropriate for the defense in the case of claims. In the case of personal data obtained exclusively for participation in the initiative, the data will be deleted within two calendar years starting from when the initiative takes place. With reference to any consent given for the purposes of corporate communication or profiling, the period is limited to 24 or 12 months respectively from the date of registration.

## 6. Data Controller and Data Processors and rights of the data subject

The Data Controllers may be contacted to find out the categories of personnel authorised to process personal data in a capacity as the person in charge of the processing or the data processor.

As provided for by law, the data subject has the right to know which personal data are used, their source, to verify their accuracy and request their integration or updating, or rectification or limitation. The data subject also has the right to have data processed unlawfully erased, anonymized or blocked, and to oppose on legitimate grounds the processing of their personal data and modify consent previously given.
